



## 2022 July Year-to-date financial results


## A. Financial Performance Summary

GSA recorded an income of \$ 1,685,859 for the period 1 Jan 2022 to the 31 July 2022 and expenses of \$1,269,167 ending the period with an **operating surplus of \$416,692** against a budgeted deficit of \$235k. The variance in surplus is due to the low operational costs and new initiatives being planned for later in the year.










*Note: All Admin & Association Wide Expenses is divided in the above four areas based on their percentages to support each area of work.*
