- Represents core funding allocation received under the SSAF funding agreement. GSA has also received separate one-off special purpose grants from the University of Melbourne from separate SSAF funding pools. In 2019 this additional funding received totalled \$0 (2018: \$59,700). In GSA's 2019 statement of profit or loss, a total of \$296,342 of other SSAF income was recorded, representing both the 2019 funds received and recognition of funds from 2018 which were previously held as income in advance liabilities in the statement of financial position (both of which were utilised in 2019) (2018: \$223,913).
- 2 Represents 7.1% of SSAF funding received for the year.
- Total admin costs are higher compared to previous year because major building works undertaken by UoM (commencing in 2018) have resulted in the significant loss to GSA of building rental income used to subsidize general organizational costs. To offset the loss of this alternative income source, the proportion of SSAF funding used to support administrative costs in 2019 necessarily increased. Also admin costs increased due the redundancies that occurred during the restructuring of the organization after engaging the UoM business services.
